**Fees and Charges.** The charge for standard boarding services is \$\_\_\_\_\_ per day, plus applicable taxes. The boarding rate is calculated on a per dog per night basis. The boarding rate is for Setter Slough Kennel, LLC (“SSK”) standard boarding services. Any special dietary or care needs of dog may result in additional charges and Owner agrees to pay such additional charges. All amounts owed are due upon pickup of dog by Owner. Owner must notify SSK, at least one day in advance, of Owner’s desired time of pickup. SSK will make efforts to accommodate Owner’s desired pickup time, but all pickup times will be finally determined by SSK. SSK reserves the right to refuse boarding of any dog. Owner warrants (s)he is the legal owner of dog.

**Dog’s Health.** Owner has provided a copy of dog’s most recent vaccinations record. The vaccinations record is complete, accurate, and fully details all of dog’s vaccinations. Dog has no communicable disease or any other condition that may negatively impact the health of any other animals or persons. Without limiting the generality of the foregoing, Owner represents and warrants dog has not been exposed to distemper, rabies, kennel cough, parvo or other known contagious diseases within the last thirty days, and dog is free of worms, heartworm, and fleas. If fleas are found, bathing will be done at Owner’s expense. Owner is solely responsible to notify SSK of any medical condition and/or medications required for dog at the time of booking boarding services. Owner must provide any medications in original containers, clearly labeled with name of dog, together with detailed instructions for administration of all medication.

**Indemnification.** Owner will defend, indemnify, and hold harmless SSK and its owners, officers, employees and all other agents, from and against any claim for damages to person or property arising from or in any way related to dog’s general health condition, ineffective vaccinations, any false information given concerning dog and dog’s health and vaccinations, and any actions of dog or Owner causing, in whole or in part, any such damages to person or property.

**Waiver; Limitation of Damages.** Owner waives any claims against and releases fully from liability therefor, SSK, and its owners, officers, employees and all other agents (“Released Parties”), for injury or damage which Owner or dog may suffer while being boarded by SSK or while on SSK’s business property, irrespective of being caused by any action or inaction, error or omission of a Released Party, or by any other dog under the care of or on the business property of SSK. Owner expressly assumes the risk of any such injuries or damages. Owner acknowledges and agrees the Released Parties will not be liable to Owner, with respect to dog, for any damages or loss caused by, without limitation, disease, death, escape, theft, fire, and transport. Owner acknowledges and agrees SSK will not be liable for any direct, indirect, incidental, special, consequential or exemplary damages. Owner is not entitled to recover from SSK any amount in excess of the amount paid by Owner to SSK pursuant to this agreement.

**Warranties Disclaimed.** With respect to the boarding services and any other services provided by SSK to Owner and dog, pursuant to this agreement or otherwise, SSK expressly disclaims all warranties of any kind, whether express or implied, including, but not limited to the implied warranties of merchantability and fitness for a particular purpose.

**Veterinary Authorization.** If dog becomes ill or injured, Owner authorizes SSK, at Owner’s sole cost and expense, to seek veterinary care for dog by a veterinarian chosen in the sole discretion of SSK. SSK will make reasonable effort, under the circumstances, to contact Owner prior to seeking any such veterinary care.
